

Visa 2018 FIFA World Cup Russia™ Spend & Win Terms & Conditions

- Information on how to enter this competition (hereafter referred to as the "Competition" or "Promotion") forms part of the Terms and Conditions of entry. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is open to all residents of the UAE, provided only that employees and their immediate families of Meraas and Visa Middle East FZ-LLC are ineligible to enter. If a winner is aged under 18, Meraas reserves the right to liaise with the parent or guardian in relation to the prize, in its absolute discretion.
- 3. The prizes are four packages for two people which include flights to Moscow/St. Petersburg, match tickets to the Group Stage, Quarter Final or Final of the FIFA World Cup Russia 2018 and accommodation (room nights and daily breakfast only excluding other costs) for 4 nights.
- 4. The Competition commences on March 10th 2018 and ends on April 21st 2018 ("Promotional Period").
- 5. The winners of the Competition will be announced on April 22th 2018.
- 6. The participating outlets are all outlets at City Walk, The Beach, Boxpark, The Outlet Village, Al Seef and La Mer.
- Each spend of AED 250 using a Visa consumer credit, debit or prepaid card at participating outlets will automatically qualify for one digital raffle coupon; each spend of AED 250 at Meraas-owned L&E outlets (Hub Zero, Mattel Play! Town, The Green Planet, Splash Pad, The Roxy Cinemas) will automatically qualify for two digital raffle coupons.

 - a. each spend in excess of AED 250 will be carried over for future submission;
 - b. each spend in excess of AED 250 at Meraas-owned L&E outlets (Hub Zero, Mattel Play! Town, The Green Planet, Splash Pad, The Roxy Cinemas) will only be carried over for future submission of Meraas-owned L&E eligible receipts.
